

General Regulations of the Sports Facility
STREFA FUTBOLU PODGÓRZE
Ul. Jana Dekerta 21

1. These regulations define the rules applicable at the PODGÓRZE Football Zone, ul. Dekerta 21.
2. Use of the services is permitted only after reviewing these regulations.
3. Children and adolescents under 16 years of age may use the Football Zone only with the written consent of a parent or legal guardian (the form is available at Reception).
4. Within the FOOTBALL ZONE, the following is prohibited:
 - a. using the services under the influence of alcohol, intoxicants, or other substances with a similar effect;
 - b. bringing and consuming alcoholic beverages, intoxicants, or other substances with a similar effect;
 - c. bringing animals;
 - d. trading, soliciting, or placing or leaving advertising signs without the Manager's consent;
 - e. smoking;
 - f. bringing dangerous objects;
 - g. chewing gum while participating in the activities.
5. Cleanliness and good manners are required within the Football Zone.
6. The Facility's opening hours are specified in the current offer.
7. Payment for the Facility's services is governed by the Price List or the terms and conditions of individual offers.
8. Services are purchased at the Football Zone Reception Desk.

9. Football Zone issues invoices upon request. This must be reported prior to the purchase.

10. Locker room keys are issued at the Football Zone Reception Desk. The key is issued only to the group's chaperone.

11. In the event of loss or damage to the locker room key, the customer is obligated to pay a fee of PLN 40 for the cost of replacing the lock.

12. Any damage to Football Zone property caused by the customer's actions or omissions will be fully financially responsible. In the event of damage caused by minors, the guardians will be held liable. Until the customer's access to the Football Zone services is suspended.

13. The Football Zone is not responsible for items left by Customers on the premises, including for loss or damage. Customers are required to store any items brought in in the facility's locker rooms. The Football Zone is not responsible for balls kicked outside the facility.

14. Customers should use the rooms and equipment in the Football Zone for their intended purpose and in the manner indicated by a Football Zone employee or in accordance with the applicable instructions or information regarding their use. During use of the pitch, equipment may only be transported in such a way that it does not come into contact with the playing surface.

15. Activities for children and youth using the Football Zone facilities may only take place in the presence of a teacher (instructor, coach).

16. By using the Football Zone, Customers declare that they have no health contraindications to physical exercise and use the services offered by the Football Zone at their own risk. Anyone wishing to use the Football Zone should consult a physician regarding their health status beforehand.

17. The Football Zone and its employees are not responsible for any injuries resulting from the use of the equipment.

18. Persons using the Football Zone are required to wear sportswear and a change of sports footwear. For hygiene reasons, it is also recommended to bring a towel. When using the artificial pitch, only sports shoes with low rubber or plastic studs and indoor shoes are permitted. Shoes with metal, aluminum, ceramic studs, or spikes are strictly prohibited.

19. Persons using the facility are required to check the safety devices for the goals on the pitch before each use. We use safety devices (weights) available within the pitch to secure the goals.

20. Health and safety regulations and fire safety regulations must be strictly observed throughout the facility and its surroundings.

21. Cancellations may only be made using the cancellation form used by the Provider or by email to biuro@futbolstrefa.pl, at least two days before the cancelled date. Cancelling a reservation by any other means will have no effect, and the person making the reservation is obligated to pay for the reserved date.

22. The controller of data provided by individuals using the FUTBOLU ZONE is FKK Partners Sp. Z O.O. Sp. KO.

Participation in classes constitutes consent by users of the Futbolu Zone (or their guardians) to the processing of their personal data in the following scope:

- a) address, identification (to the extent necessary to organize, conduct, and bill for the use of the Futbolu Zone services), and image;
- b) purpose of processing: organization, conduct, and bill for the use of the Futbolu Zone services; promotion of the activities of Strefa Futbol and other legitimate interests of Strefa Futbol;
